#### Blessed Maria Gabriella (1914-1939)

CISTERCIAN NUN WOMAN OF UNITY BEATIFIED ON JANUARY 25th 1983



Maria Sagheddu was born in Dorgali in Sardinia in 1914, the fifth of eight children. Her father was a shepherd and died while she was a child, thus leaving to the mother, Caterina, the task of bringing up the children. The home was a traditional pious Catholic household, and the family had to work hard to make a living.

During the early year of her life Maria was not notable for piety. In fact some of her neighbours recalled that she had been somewhat remiss in her duties at times, and while she was regular in going to Sunday Mass, she was not so about receiving the Sacraments and about prayer. If her mother told her to go to Benediction, the girl would as likely as not reply "Go yourself".

When she was eighteen, Maria's sister died. She was emotionally close to this sister and the death led to a conversion experience. We do not know the details of this, but certain it is that henceforth Maria started going to daily Mass and communion and gave herself to long periods of prayer. She took part in good works in the village, a thing she had hitherto declined to do, and taught the small children their catechism. The Pastor became her spiritual guide and two years later Maria told him she wished to become a nun. He directed her to the convent of Grottaferatta, a Cistercian convent near Rome and she

entered there in 1935.

At this time the Abbess of the monastery was a close friend of the Abbe Couturier, a French priest who was a great apostle of Church Unity and in particular of prayer for Unity. Couturier pointed out that actual Unity could be a very long way off, but we can all pray now for this great intention, prayed for by jesus at the Last Supper.

Sr. Gabriella as she now was, took up this idea enthusiastically and after her profession decided to offer her life to God for this intention, taking the words of Jesus literally about laying down your life for your friends.

She made the offering and soon afterwards contracted TB, and spent almost a year in a sanatorium. Despite this and all the medical aid she got, the disease could not be stopped and she died in 1939, aged just 25.

After her death, word of it and of her piety spread and gradually her cult began and grew. Her cause was introduced at Rome in 1953 and now she has been declared Blessed.

Her holiness lay in doing what she could. She could not work for Unity so she prayed for it; she knew little of the causes of disunity but she knew what God's will was and this was the beacon light of her short life. This is her message to us: "Do what you can, where you are . . . pray and do God's will and that will bring Unity sooner than anything".


childrens' hospital. Much of the surplus food was given to an equally worthy cause.

#### THE PRESIDENT'S LETTER

To the Central Committee of the Roscrea Past Pupils Union I would like to say a sincere thank you for the honour you have bestowed on me by electing me to be your President for the next two years. I am very appreciative of your trust and confidence.

In a community as closely knit as our own, our Union achievements are very well known to other school Unions in the country and our achievements are the envy of most.

Central Committee are continuously examining our function with a view to expanding our activities and bringing the Union closer to the more recent Past. Past students of the College, not Members of the Union, should make themselves known to their local Branch Chairman and join the Union or write for application forms to the General Secretary of the Union, Rev. Fr. Dermot O Colmain O.Cist., at the College. In mentioning Fr. Dermot it gives me an opportunity to express our deep appreciation to him for his dedication and commitment which in no small measure is responsible for the furtherance and development of our Union over the last decade or so. We are very grateful to you, Fr. Dermot, for your enormous input which is sincerely appreciated by all of us, and for your friendship.

I would now like to alert you to a very serious problem concerning our Union. The problem is lack of money.

Union revenue is derived from two sources:-

(1) Subscriptions received towards the quarterly issue of the Roscrea Review;

(2) Subscriptions received from new members.

The total funds receivable from these sources is only a fraction of the resources necessary to cover the running costs of your Union. For example, the cost to print the

"Roscrea Review" quarterly and post to our 1,600 members is IR£3,200 annually. The cost of printing and postage has soared in recent years and the problem is that subscriptions received to offset these increases have not kept pace. Your President is encouraged by the views expressed concerning the state of our finances by the members present at the Annual General Meeting of the Union held in the College on the 4th October 1982. The members were of the opinion and in no doubt that the "Roscrea Review" must continue to issue — it being the link between the Past, the Present, the College and the Monastery.

I am, therefore, pledging my Presidency to putting the finances of our Union in order to insure that it has a sound financial base. With your help and working together for the same purpose during my term as President I will also commit my energies to re-establishing the dormant Branches of our Union. Immediately the Winter issue of the Review is circulated to our Union members I will be writing to the Chairman and Secretaries of each Branch to arrange an informal meeting which I will attend for the purpose of putting before your Branch members the recommendation of Central Committee, which is to boost Union funds by way of annual subscription to the Review fund to ensure that your Union is able to pay its way in the future. Otherwise Union activity will come to a halt unless there is an immediate injection of capital into central funds.

There is no room for complacency now. I look forward very much to working with our members with enthusiasm at Branch level and at Central Committee in the name of our beloved "Roscrea Union" to make certain that our goal is achieved.
